Rekwiziti tal-Eligibbiltà

2. L-applikanti:

- a. għandhom ikunu ċittadini Maltin;
- b. għandhom ikunu għalqu t-tmintax (18)-il sena sad-data tal-għeluq tal-applikazzjoni iżda ma jkunux għalqu t-tletin (30) sena sal-31 ta' Diċembru 2019;
- ċ. għandhom ikunu ta' karattru morali tajjeb;
- d. għandhom ikunu twal tal-anqas 1.57m fil-każ tal-irġiel u 1.52m fil-każ tan-nisa u ta' piż aċċettabbli pparagunat mat-tul;
- e. m'għandhomx ikollhom *tattoos* eċċessivi, imma żgur mhux fuq il-wiċċ u l-għonq jew *tattoos* li huma offensivi, estremisti, indeċenti jew razzisti fuq partijiet oħra tal-ġisem;
- f. (i) ikollhom ċertifikati fil-lingwa Ingliża, dik Maltija u l-Matematika f'livell MQF 2 (b'minimu ta' Grad E jew 7, jew livell komparabbli);

1. The Director of Examinations invites applications for the enlistment of soldiers having a technical background and musicians to serve as soldiers and to work in their specialisation, as enlisted, in the Regular Force of the Armed Forces of Malta.

Eligibility Requirements

2. Applicants must:

- a. be Maltese citizens;
- b. be eighteen (18) years of age by closing date of application and not have reached the age of thirty (30) by 31 December 2019;
- c. be of good moral character;
- d. be not less than the minimum height required, i.e. 1.57m for males and 1.52m for females and of acceptable body weight in proportion to height;
- e. not have excessive tattoos, but definitely not on face and neck or tattoos that are offensive, extremist, indecent or racist on any part of the body;
- f. (i) be in possession of a pass in English language, Maltese language and Mathematics at MQF Level 2 (at least at Grade E or 7, or a comparable level);
or
(ii) be in possession of a recognised qualification at MQF Level 2, or a Secondary School Certificate and Profiling qualification at MQF Level 2,

3. Qualifications at a level higher than that specified above will be accepted for eligibility purposes, provided they meet any specified subject requirements.

4. Selection Process

4.1 The Selection Process consists of:

Part I - Physical Efficiency Test
 Part II - Written Examination (as per para 2(f)(iii))
 Part III - Interview
 Part IV – Military test
 Part V - Medical Examination

Parts I, III and IV shall be held on the same day. Applicants shall be provided with the relevant information in due course.

4.2 Applicants who, for any reason, fail to attend or complete any part of the Selection Process will be considered to have withdrawn their application.

4.3 Applicants who at any time are found not to fulfil the requirements laid out in paragraph 2 shall not be allowed to proceed with the Selection Process and shall have their results annulled.

4.4 Vacancies, for this call, will be filled in accordance with the final order of merit pertaining to this call. The validity of the final order of merit will expire after eight months from publication of the final result. The final order of merit, pertaining to this call, will be determined by the total points gained in the Selection Process as follows:

5. Parti I - Eżami tal-Effiċjenza Fiżika

5.3 L-applikanti jridu tal-anqas jilħqu l-*standard* minimu f'kull test fiżiku biex jitqiesu li għaddew mill-Eżami tal-Effiċjenza Fiżika.

5.4 L-applikanti li ma jgħaddux minn wieħed mit-testijiet fiżiċi, jew il-1 *mile run* jew il-*push-ups* jew is-*sit-ups*, ikunu jistgħu jerġgħu joqogħdu għal *re-sit* ta' dak it-test wieħed partikolari, fi żmien mhux inqas minn 10 t'ijiem wara li jkun sar l-ewwel test komplut, iżda xorta ma jkunux intitolati għal iżjed mill-marka minima ta' 150, irrispettivament mill-marki miksubin fit-testijiet l-oħra.

6. Parti II – Eżami tal-Kitba

6.1 Punt miksuba f'din il-Parti ma jiġux ikkunsidrati fl-ordni finali tal-mertu.

Part III – Interview (Points: Maximum 300, Minimum 150. An additional maximum 100 points may be given for additional qualifications, provided that applicants obtain a minimum of 150 marks in the Interview).

4.5 The list of applicants eligible, as per paragraph 2(f)(i) and (ii), for Part III – Interview, shall be published on the Department of Examinations notice board, together with the result of Part II – Written Examination.

5. Part I - Physical Efficiency Test

5.1 Part I of the Selection Process will be conducted by the Armed Forces of Malta. Applicants will be checked for height in order to ensure that they meet the requirements stipulated in paragraph 2 of this call. Applicants shall be required to pass a Physical Efficiency Test to ensure fitness to Regular Force standards.

5.2 The minimum standards are as follows:

- a. 1 *mile run* - not more than 8 minutes and 30 seconds for males, and 10 minutes and 18 seconds for females;
- b. *Push-ups* - not less than 30 repetitions for males and 11 repetitions for females in a timed period of 2 minutes;
- c. *Sit-ups* - not less than 37 repetitions for males and 35 repetitions for females in a timed period of 2 minutes.

5.3 Applicants must at least attain the minimum standard in each physical test to be considered as having gained a pass in the Physical Efficiency Test.

5.4 Applicants who fail in one feat only, i.e. either the 1 *mile run* or the *push-ups* or the *sit-ups*, will be allowed to re-sit that one particular event not less than 10 days following the first complete test, but if successful in such re-sit will only be entitled to the minimum pass mark of 150, regardless of the scores obtained in the other feats.

7. Parti III - Intervista

6. Part II - Written Exam

6.1. Marks obtained in this Part will not be taken into consideration in the final order of merit.

6.2 Part II of the Selection Process will be conducted by the Director of Examinations and the Board of Local Public Examinations. Applicants who are not in possession of the qualifications specified in paragraph 2(f)(i) and/or (ii) and/or are in partial compliance with minimum requirements of written examinations of previous calls as per paragraph 2(f)(iii), have to sit for a written examination in the required subject/s (English language and/or Maltese language and/or Mathematics). The exam shall be in multiple choice format. Each examination paper shall be of a one-hour duration. Non-scientific calculators are allowed during the examination. Examination shall be published and displayed on the Department of Examinations notice board. Applicants may request a revision of paper/s by not later than 10 working days from the date of publication of results, according to the conditions established by the Department of Examinations which will be communicated in due course.

7. Part III – Interview

7.1 Part III will be conducted by the Armed Forces of Malta. The interview is designed to assess an applicant's suitability for military service. Applicants are required to obtain a minimum of 150 points to be considered further. The result is final.

7.2 In the event of failure in the interview, no points will be allocated for additional qualifications.

7.3 Points for additional qualifications will be allocated as shown hereunder:

MQF level 4 – 15 points per subject
MQF level 3 – 10 points per subject
MQF level 2 – 5 points per subject
(except for core subjects)

7.4 Results pertaining to the Interview and Military Test shall be published and displayed on the Armed Forces of Malta notice board.

7.5 With the exception of those qualifications referred to in paragraphs 7.6 and 7.7 hereunder, applicants are required to produce a recognition statement by the Malta Qualifications Recognition Information Centre (MQRIC) within the National Commission for Further and Higher Education (NCFHE), which is to be obtained by submitting an online "Application for the Recognition of Qualifications" at <https://services.ncfhe.gov.mt/CertificationApplication.aspx>. Such statement should be attached to the application and the original presented at the interview.

7.6 Prior to requesting recognition statements as per paragraph 7.5 above in respect of their qualifications, applicants should first consult the "List of Accredited Courses Offered by Licensed Institutions" of the NCFHE which can

10.3 Vetting will be in accordance with AFM policies.
